ORDER:

In the reference 2nd cited, orders were issued indicating General/Major ailments and their ceilings for the treatment of Employees/Pensioners/Family Pensioners and their dependents.

2. The Unions/Associations were represented for Unlimited Medical Policy. As per the Memorandum of Settlement in the Meeting held on 01.09.2018 at Pragathi Bhavan, the Hon'ble Chief Minister has announced 35% of fitment and better medical policy to all the employees and pensioners of TSTRANSCO, TSGENCO, TSSPDCL & TSNPDCL in the presence of Special Chief Secretary to Government, Energy Department, Telangana Government and Chairman & Managing Director/TSTRANSCO, TSGENCO and CMDs/DISCOMs.

3. The CMD/TSTRANSCO after careful examination and in consideration of the report submitted by the Pay Revision Negotiating Committee'2018 constituted vide T.O.O(Jt.Secy-Per) Ms.No.94, dt:30.04.2018 has convened Meeting with the Unions/Associations on 05.09.2018, wherein consensus has been reached with Unions/Associations and entered into Memorandum of Settlement.

4. In the Memorandum of Settlement of Unions/Associations at para 11 (d), it is agreed for enhancement of General/Major/SFMS Ceilings and contribution towards SFMS for the treatment to Employees/Pensioners/Family Pensioners and their dependents as detailed below;

Sl. No.	Existing General/Major/SFMS Ceilings	Enhanced as per the Memorandum of Settlement dt:05.09.2018
1	The maximum ceiling limit of Rs.2.00 lakhs is fixed for all the minor ailments/diseases for life time with effective from 01.04.2009 for all Employees/ Pensioners and their dependents/ Family Pensioners. T.O.O.Ms.No.16,dt:08.04.2011.	The maximum general ceiling limit is enhanced to Rs.5.00 lakhs per family is fixed for all the minor ailments/diseases for life time for Employees/Pensioners/Family Pensioners and their dependents.
2	A maximum ceiling limit of Rs.2.00 lakhs (Rupees Two Lakhs only) is fixed for each time and each ailment separately for different major ailments/surgeries/ treatments i.e., CABG, Double Valve Replacement, Kidney Transplantation, Cancer, Neurosurgery, Aortic Valve Replacement, PTCA Stent be restricted to three spells for each of these diseases. Three spells means three surgeries for same ailment. T.O.O.Ms.No.16, dt:08.04.2011.	The maximum ceiling limit of major ailments is enhanced to Rs.12.00 lakhs for life time @ Rs.4.00 lakhs each time in three spells for each ailment separately for major ailments /surgeries/treatments i.e., CABG, Double Valve Replacement, Kidney Transplantation, Cancer, Neurosurgery, Aortic Valve Replacement, PTCA Stent. Three spells means three surgeries for same ailment.
3	The Self Funding Medical Scheme was introduced duly contributing Rs.100/- per month by all Employees/ Pensioners towards medical expenditure by extending Rs.3.00 lakhs per family per year over and above the minor ceiling and major ceiling as per the CGHS tariff rates. T.O.O.Ms.No.92, dt:16.06.2012.	The Self Funding Medical Scheme is enhanced to Rs.6.00 lakhs per family per year over and above the minor ceiling and major ceiling as per the CGHS/NIMS tariff rates and enhanced the monthly contribution from Rs.100/- per month to Rs.500/- per month from Employees/Pensioners, Family Pensioners. It will be reviewed every 6 months.

5. The enhanced General/Major/SFMS Ceiling limits come into force with effect from the date of issue of this order. Further, the employees/pensioners who have already availed medical facility prior to this order, the same will be adjusted from the enhanced ceilings.

6. The enhanced contribution of Rs.500/- per month towards Self Funding Medical Scheme will be deducted from the Salary/Pension/Family Pension of September-2018 payable in the month of October-2018 from Employees/ Pensioners/ Family Pensioners.

7. This order shall come into force for the treatment taken on or after the date of issue of the order.

8. The other orders relating to existing medical scheme issued from time to time holds good.

9. This order is issued with the concurrence of Joint Managing Director (Finance, Comml. & HRD) vide Regd.No.4006, dt.11.09.2018.
