#### ORDER:

It is necessary for APTRANSCO to expand existing transmission network by commissioning new EHV transmission lines and Substations to meet the system demand and for transmission of quality power from time to time. In view of the manifold expansion of power system network, it is essential for strengthening of certain field units such as Substation & Lines, Divisions, Circles and Zones etc. Thus it necessitates sanction of additional posts for construction of new lines & Substations and operation & maintenance of lines & Substations already commissioned. In this context, the Technical Committee reviewed the workload and based on the recommendations of the Committee, proposals were sent to Govt. for creation of 870 Electrical Engineering posts for re-organisation of APTRANSCO in Field and headquarters.

2. After careful examination, the Govt., have accorded sanction for creation of 297 Electrical Engineering posts. Accordingly, the APTRANSCO vide T.O.O (2) cited issued orders for creation of the following 297 Electrical Engineering posts duly adopting the Govt., G. O (1) cited.

3. In continuation to the said orders, APTRANSCO hereby accords approval for fixation of headquarters/ allotment of the newly sanctioned posts of 1 CE/Elecl, 3 SE/Elecl & 24 DEs/Elecl., and for redesignation/ change of control of the existing posts of 1 CE/Elecl., 3 SE/Elecl., & 12 DEs/Elecl., as follows.

#### A) Fixation of Headquarters/ allocation of newly sanctioned posts:

### a) Chief Engineer (Electrical) - 1 No.

CE/TL&SS/ Rural Zone/ Hyderabad: The existing CE/TL&SS/ Hyderabad Zone has been managing the O&M and construction activities of the jurisdiction of Hyderabad, Ranga Reddy, Nalgonda, Mahaboob Nagar and Medak districts. Due to formation of GHMC, it is felt necessary for effective & close monitoring of O&M works of Twin Cities & RR district including construction of GIS Substations and laying of XLPE cables etc. The Technical Committee after review of workload opined for formation of new Zone duly bifurcating the existing CE/TL&SS/ Hyderabad Zone.

Accordingly, it is hereby ordered that new TL&SS Zone shall be formed duly bifurcating the existing TL&SS Zone/ Hyderabad to look after the O&M and construction functions of EHV Lines & Substations in Nalgonda, Mahaboob Nagar and Medak districts, with Zonal office headquarters at Hyderabad and the Chief Engineer/Elecl. shall be designated as CE/TL&SS/ Rural Zone/ Hyderabad.

#### b) Superintending Engineer (Electrical)- 3 Nos

- (i) <u>SE/Co-ordination/ Vidyutsoudha</u>:- 1 new SE post shall be kept under the control of JMD(HRD, Comml, IPC &IT) to co-ordinate the CEs viz., CE/Commercial/APTransco, CE/Grid Operation, CE/Commercial/APPCC and CE/IPC with respect to power purchase related matters.
- (ii) <u>SE/TL&SS/ Mahabubnagar</u>:- New TL&SS Circle shall be formed duly bifurcating the existing TL&SS Circle/ Hyderabad to look after the O&M functions of EHV Lines & Substations in Mahabubnagar district with Circle office headquarters at Mahabubnagar and the Superintending Engineer/Elecl. shall be designated as SE/TL&SS/ Mahabubnagar. The Circle is kept under the control of new TL&SS Zone Rural Hyderabad.
- (iii) <u>SE/TLC/Rural /Hyderabad</u>:- New TLC circle shall be formed duly bifurcating the existing TLC Circle/ Hyderabad to look after construction activities of EHV Lines & Substations in Nalgonda, Mahaboob Nagar and Medak districts with Circle office headquarters at Hyderabad and the Superintending Engineer/Elecl. shall be designated as SE / TLC /Rural / Hyderabad. The Circle is kept under the control of new TL&SS Zone Rural Hyderabad.

Accounts and P&G staff, pay& allowances and other services etc.

In case of formation of new/ bifurcation of the existing divisions jurisdiction and workload, all the functional heads incl. CE/Civil and CE/Telecom shall reallocate the corresponding Sub-divisions/ Sections under their control and take necessary steps (incl. providing infrastructure) based on the above allocation, workload/ geographical jurisdiction and

report compliance to APTRANSCO / Vidyut Soudha.

7. Separate orders will be issued for fixation of headquarters for the newly created posts of 179 ADE/Elecl, 50 AE/AAE(Elecl.,) and 40 Sub-Engineer/ Elecl., and for allotment of

supporting staff posts such as Accounts, P&G, other Engg staff to new Zone/ Circles.

8. The incumbents against the posts allotted herein shall be eligible to draw the usual scales of pay and allowances as admissible at the place of their duty as per rules in vogue.
