During the circulation of proposal for augmentation of Power Transformer capacities at 132 kV substations Narsapur and Kandi, Director (Grid Operation) felt that strengthening of 132 kV system is to be taken up by erection of new 132 kV line from 220/132 kV substation Yeddumailaram to 132/33 kV substation Pashamailaram simultaneously.

The feasibility report and route proposed for the erection of proposed 132 kV DC line from 220/132 kV SS Yeddumailaram to 132/33 kV SS Pashamailaram submitted by SE/TLC/Rural /Hyderabad is as follows.

- a. The space for 132 kV bay extension at 220/132 kV substation Yeddumailaram and at 132/33 kV substation Pashamailaram is available.
- b. The area between 220/132 kV substation Yeddumailaram and 132/33 kV substation Pashamailaram is fully industrial area and there is no corridor for laying of the 132 kV line. As such, it is proposed to lay 132 kV line along the R & B Road boundaries with Narrow Base towers.
- c. The length of the BEE line is 5.6 KM and the proposed line length is 7.0 KM.

Chief Engineer/Construction-I formulated a scheme for erection of 132 kV DC/SC line with Narrow based towers from 220 kV Yeddumailaram SS to 132 kV Pashamailaram SS and erection of 132 kV bays at 220 kV Yeddumailaram SS and Pashamailaram 132 kV SS and has proposed to pose the scheme to M/s. Power Finance Corporation Ltd., New Delhi / M/s Rural Electrification Corporation / and other financial institutions for sanction of loan.

After careful consideration, APTRANSCO accords approval for the above scheme at a total cost of **Rs. 931.00 Lakhs** with latest SSR rates as per the break up indicated below:
