The proposal for erection of 132/33 kV substation at Ramapuram in Nalgonda district was received from APCPDCL. On submitting feasibility report for the proposed 132/33 kV substation at Ramapuram in Nalgonda district, SE/TLC/ Rural/Hyderabad intimated that erection of 132/33 kV SS at Ramapuram is not feasible as there is no Government land available in and around Ramapuram village for the construction of substation and the upcoming feeders to the proposed 132/33 kV Ramapuram substation is not possible as the majority of area is under Mining and cultivation.

SE/TLC/ Rural/Hyderabad also intimated that approval was accorded for erection of 132 kV line and substation for CKoromandal Cements, which is very near to Ramapuram village and the proposed line corridor and the substation site is being given by M/s. CKoromandal Cements at free of cost to APTRANSCO. In this substation site, provision is made for erection of 33 kV features, which can be utilized to feed the nearby loads.

In this connection, Chief Engineer/Power systems informed that the erection of 33 kV features in the 132 kV CKoromandal Cements (Ramapuram) Switching station in Nalgonda district may be taken up based on the field feasibility and requirement.

SE/TLC/ Rural/Hyderabad confirmed that space provision is available for erection of 33 kV features in the proposed 132 kV Switching station at Ramapuram (CKoromandal Cements) in Nalgonda district.

Chief Engineer/Construction-I formulated a scheme for providing 33 kV features in proposed 132 kV Switching station at Ramapuram (Ckoramandal Cements) in Nalgonda district with 2 Nos. 16 MVA Power Transformers (released transformers) and has proposed to pose the scheme to M/s. Power Finance Corporation Ltd., New Delhi / M/s Rural Electrification Corporation Limited, New Delhi / other funding agencies for sanction of loan.

After careful consideration, APTRANSCO accords administrative approval for the above scheme at a total cost of **Rs. 418. 00 Lakhs** as per the break up indicated below:
