## **ORDER:**

APTRANSCO noticed that certain Discoms have placed purchase orders on the companies owned by promoters of black listed companies.

After careful examination, the APTRANSCO decided to implement the following for avoiding of placing of purchase orders on the companies owned by Promoters of Black Listed Companies or dubious companies.

- 1. Not to do vendor registration of the companies promoted/owned by already blacklisted companies.
- 2. To take action to verify all vendors registered in the companies immediately with reference to promoters of blacklisted companies to also blacklist them.
- 3. To place all the Purchase Orders of all circles /zones of the APTRANSCO in the APTRANSCO web-site without fail.
- 4. Once in a quarter, all work contracts/purchase orders of material awarded on nomination basis should be reviewed at Board level.
- 5. Declaration of relationship clause should be ensured in all tender specifications of work contracts and material supply irrespective of the value. Any wrong declaration or hiding of information on this regard should be viewed seriously and such firms should be blacklisted/debarred. If any tender is floated without declaration of the relationship clause, officers responsible for such mistake should also be punished.
- 6. Incorporate following clause in all future tender specifications:

  "The companies would be ineligible to participate in tenders which are blacklisted by any other utility and whose promoters' firms or companies were already blacklisted/debarred by any other utility".

- 7. An undertaking should be taken from the companies regarding point No.6 to make them ineligible or to terminate contract if information furnished in this regard is found false at later date.
- 8. APTRANSCO directs all the concerned officers to follow the above points scrupulously to avoid placing of purchase orders on the companies owned by promoters of black listed or dubious companies.
