- c) To pro-actively monitor all legal issues / judicial cases and maintain follow ups of all cases pertaining to APTRANSCO to ensure timely and effective action.
- d) To transmit the Notices / Court Orders / Judgments to Legal Cell, APTRANSCO for further action
- e) To attend the SLAs/Advocates office daily and hand over relevant information/case material, if any, to the SLAs/Advocates from concerned wing and also to communicate the instructions of SLAs/Advocates to the concerned.
- f) To procure case material, certified copies and other relevant documents of a particular case/cases on instructions of Legal Cell or Legal Advisor, APTRANSCO.
- g) To have effective coordination on day-to-day case proceedings with Advocates/SLAs, Legal Advisor and Legal Cell for effective handling of the legal cases pertaining to APTRANSCO before various Courts.
- h) To work under administrative control of Legal Cell, APTRANSCO.
- i) Any other Legal Cases and Court related works entrusted by Legal Cell or Legal Advisor, APTRANSCO.
