ORDER:

Vide reference 1st cited, the Chief Engineer, Construction-I has informed that the revised administrative approval was accorded for erection of 220/132/33 KV SS at Raidurg along with connected EHT lines vide T.O.O. (CE-Construction) Ms.No.225, dt.07.09.2011 to cater the upcoming loads in and around Raidurg area.

The Chief Engineer, Construction-I has also informed that the Zonal Manager, APIIC has allotted an alternate land to an extent of 5.00 acres in Plot.No.23 in Sy.No.83/1 at Hyderabad Knowledge city, Raidurg (Village), Serilingampally (Mandal), Ranga Reddy District on lease basis for a period of 30 years for erection of 220 KVSS Raidurg and requested for sanction of an amount of Rs.20,000/- (i.e. Rs.1000/- per acre per annum and Rs.15,000/- towards security deposit for 3 years) to be paid to APIIC towards security deposit for 3 years and advance lease rent for 1 year.

After careful consideration of the above proposal, the Transmission Corporation of A.P. Limited accords approval to the the Superintending Engineer / TLC / Metro / Hyderabad for an amount of Rs.20,000/- (Rs.15,000 + Rs.5000) to be paid to APIIC towards security deposit for 3 years and advance lease rent for 1 year respectively (i.e. Rs.1000/- per acre per annum for 5 acres).

The Superintending Engineer / TLC / Metro / Hyderabad is directed to get the lease deed registered by paying the required stamp duty and registration charges and is authorized to take further action in this regard.
