ORDER

APTRANSCO after careful consideration has agreed to fix a consolidated amount of Rs.1,00,000/- (Rupees Two Lakhs Twenty Five Thousand only) towards fee @Rs.50,000/- per case towards appearance of Sri Pradip Bhandari, Advocate, Chandigarh on behalf of APTRANSCO in OP.Nos.522 and 523 of 2010 filed by APTRANSCO (*Cases transferred from City Civil Court, Hyderabad to District Court, Chandigarh as per Hon'ble Supreme Court of India directions and Shall be re-numbered afresh*) against the Awards Dt.21-06-2010 passed by Haryana Micro and Small Enterprises Facilitation Council, Chandigarh in respect of P.O.Nos.8817, Dt.31-10-1995 and 9373, Dt.25-05-1998 placed by erstwhile APSEB.

2. In exercise of powers delegated vide T.O.O.(P&G-Per) Ms.No.161, Dt:29-07-2006, the Joint Managing Director (HRD, Comml., IPC & I.T), APTRANSCO hereby accords sanction for payment of **Rs.50,000/-** (Rupees Fifty Thousand only) to **Sri Pradip Bhandari, Advocate, Chandigarh** towards 50% fee (@Rs.25,000/- per case) out of total fee of Rs.1,00,000/- for appearance on behalf of APTRANSCO during the initial stage in the said two cases (yet to be numbered) transferred from City Civil Court, Hyderabad to District Court, Chandigarh as per Hon'ble Supreme Court of India directions. Sanction is also accorded for payment of **Rs.6,180/-** (Rupees Six Thousand One Hundred and Eighty only) towards Service Tax @12.36% on the amount sanctioned to the Advocate. The balance 50% fee is to be released after disposal of the said two Cases.

3. The Accounts Officer/ CPR/APTRANSCO/ Vidyut Soudha/ Hyderabad is requested to arrange for payment of **Rs.50,000/-** (Rupees Fifty Thousand only) sanctioned in para (1) above by cheque in favour of "**Sri Pradip Bhandari, Advocate, Chandigarh**". It is also requested to arrange for remitting the Service Tax amount of **Rs.6,180/-** (Rupees Six Thousand One Hundred and Eighty only) to **Service Tax Department, Govt of India**

4. The said two Cases are registered in LCMS Application as "881-2011 & 882-2011"
