ORDER:

Under Regulation 14(a)(1) of A.P.S.E.Board S.Rs-Part-II, as adopted by APTRANSCO, Sri D. Abraham, Superintending Engineer/Elect., is promoted temporarily to act as Chief Engineer/Elect., with effect from the date of assumption of charge.

2. The promotion ordered in para-1 above is purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.

3. The promotion ordered is also without prejudice to the seniority of the Officers that will emerge after review of F.C.G List of Asst. Engineers of Electricity Department as on 1-11-1956 is finalized.

4. The above promotion is subject to the result of Appeal filed by the retired officers of erstwhile APSE Board against the judgement in W.P.No.2360-91/83 and pending in the Hon'ble Supreme Court and is also subject to result of W.P.No. 4219 of 1978, and 24489/2006 pending in Hon'ble High Court of A.P.

5. Sri D. Abraham., Superintending Engineer/Elect on temporary promotion as Chief Engineer/Elect., ordered in para-I is transferred and posted as CE/SLDC/VS/Hyd vice Smt. K. Sudha Rani, CE/SLDC/VS/Hyd is transferred.

6. On transfer Smt. K. Sudha Rani, CE/SLDC/VS/Hyd is posted as CE/Transmission/VS/Hyd in the existing vacancy. She is requested to assume charge at the place of posting ordered after obtaining proper relief at the present place of working.

7. The Controlling Officer is requested to relieve Sri D. Abraham, Superintending Engineer/Elect., by making local arrangements pending posting of substitute to enable him to assume charge on promotion as Chief Engineer/Elect at the place of posting ordered.

8. The promotee is requested to assume charge on promotion as Chief Engineer/Elect., at the place of posting now ordered after obtaining proper relief at the present place of working.

The promotee is informed that any request for change of posting will not be entertained and he shall assume charge accordingly after obtaining proper relief from the present place of working within 15 days from the date of receipt of these orders, failing which he has to forego all the rights both at present and in future for such higher post. If he fails to join duty within the time limit or evades to join duty such period till he re-joins will be treated as un-authorized absence, besides treating such period of un-authorized absence as 'DIES-NON'. He shall also be liable for disciplinary action.
