## **ORDER:**

- 1. The Chief Engineer, Construction-II, Vidyut Soudha in his letter 1st read above has given a clarification regarding the format of gift deed for transfer of assets created by the Bulk load consumers/ Generators and also it was indicated that the Gift deed is to be made on a Rs.100/- notarized stamp paper. Subsequently, the FA & CCA (CF) vide letter dt:Lr.No.38/2013, dt:05.02.2013 has informed that the transfer of assets through notarized gift deed is not valid and registration of Gift Deed is mandatory for capitalization of assets and for claiming depreciation .The above matter was deliberated by the Board on 14/05/2013 and the following was decided:
  - 1) All the assets created by the Bulk load Consumers/ Generators are to be transformed to APTRANSCO by way of a registered Gift Deed.
  - 2) The expenditure towards registration charges are to be borne by APTRANSCO.
  - 3) Transfer of assets to APTRANSCO by private bulk consumers/ Generators is mandatory and has to be complied with.
  - 4) In case of State/ Central Govt.organizations which cannot transfer assets due to Govt. regulations, the property may be handed over to APTRANSCO by way of 99 years lease on a nominal rent of one rupee per year.
- 2. The Chief Engineer, Construction-I, APTransco, Vidyut Soudha in his letter 2<sup>nd</sup> read above has submitted the proposal for reimbursement of Gift Deed registration cost of Rs.36,470/- to M/s. Aryhama Solar Plant Pvt Ltd stating they have purchased required land to an extent of 30 X 39m adjacent to 132 KV SS Kolanpaka and registered the same as Gift Deed in the name of APTransco on 25<sup>th</sup> October 2013 which is required for 33 KV Bay extension at 132 KV SS Kolanpaka towards power evacuation from 6 MW Solar Power Plant at Kolanpaka and requested for according necessary approval.

- 3. After careful consideration of the above proposals, the Transmission Corporation of Telangana Limited accords approval to the Superintending Engineer, O&M, Nalgonda for an amount of Rs.36,470/-towards reimbursement of gift deed registration cost to M/s.Aryhama Solar Plant Ltd.
