 - c) for sanctioning of Telangana Increment to the self relieved employees in terms of G.O.Ms.No.23 Finance (HRM.III) Department Dt.13.08.2014 issued by Government of Telangana as adopted by TSTRANSCO vide T.O.O.Ms.No. 12, Dated.27.08.2014
- 4. It is further ordered that the self-relieved employees are entitled for above monetary benefits as per their eligibility with effect from their date of joining in TSTRANSCO, subject to the condition of final bifurcation of employees between APTRANSCO and TSTRANSCO.
