In exercise of powers delegated vide T.O.O.(P&G-Per) Ms.No.161, Dt:29-07-2006 as adopted by TSTRANSCO vide Office Order No.CGM(HRD, Trg & LIS)/DS(P)/AS/PO(IR&Reg)/ JPO/01/14, Dt.12-06-2014, sanction is hereby accorded for payment of **Rs.55,000/-** (Rupees Fifty Five Thousand only) to “**M/s.MSA Partners, Advocates, New Delhi**”, which includes Rs.50,000/- towards fee for appearance on 20-06-2017 and for drafting and finalizing rejoinder, and Rs.5,000/- towards clerkage @10% of fee in Petition No.237/TT/2016 filed before CERC, New Delhi with regard to determination of tariff of the inter-State transmission lines, consequent upon bifurcation of state of Andhra Pradesh, of APTRANSCO as per the Central Electricity Regulatory Commission's order dated 14.3.2012 in Petition No. 15/Suo-Motu/2012, for inclusion in POC transmission charges in accordance with Central Electricity Regulatory Commission (Terms and Conditions of Tariff) Regulations 2014. The details of fee and expenses payable are as follows :
