Sub: TSTRANSCO - Regulations - Conversion from Additional Assistant Engineers to Assistant Engineers who have acquired qualification of B.Tech/B.E. while in service - Clarification - Issued - Reg.

In the reference 1st cited, it was clarified that the date on which the Provisional Certificate issued by the University in token of having passed the Degree Examination shall be taken as the date on which he deemed to have obtained the Degree. The date on which the Provisional Certificate issued shall be the basis for considering such cases for promotion to the next higher cadre.

2. As per decision taken in the TSPCC Meeting held on 14.09.2016, vide reference 2nd cited, a letter was addressed to the Government of Telangana seeking clarification as to which date i.e., the last date of qualifying exam (or) the date of publication of result of qualifying exam (or) the date of issue of provisional certificate shall be taken into consideration to effect the conversion from AAE to AE who have acquired qualification to B.Tech/B.E. while in service.

3. In the letter dt.16.02.2017, the Government of Telangana, clarified to follow the instructions issued vide reference 1st cited, uniformly here afterwards, i.e., to consider the date on which the Provisional Certificate was issued, since those instructions were already in existence and they need to be followed (copy enclosed).

4. The Head of the Departments of TSTransco are hereby directed to follow the instructions issued in Memo 1st cited uniformly here after to consider the date on which the Provisional Certificate was issued by the University in token of having passed the Degree Examination.
