ORDER:

In the reference 2nd cited, the Retainer Fee of Board Legal Counsels (BLCs) appearing before Courts at District Level was enhanced from Rs.3,500/- to Rs.5000/- (Rupees Five Thousand only) per month.

2. Pursuant to the requests of BLCs, the matter of enhancement of monthly retainer fee of BLCs was discussed in the TSPCC meeting held on 17-05-2018. After careful consideration, it was decided to enhance the retainer fee to Board Legal Counsels (BLCs) from Rs.5000/- to Rs.10,000/- (Rupees Ten Thousand only) per month.

3. In accordance with the said decision of Board of TSPCC, TSTRANSCO/TSPCC hereby enhances the **monthly retainer fee** to the **Board Legal Counsels (BLCs)** appearing before Courts at District Level from Rs.5,000/- to **Rs.10,000/-** (Rupees Ten Thousand only). The applicable taxes from time to time on the payments to the BLCs shall be remitted to the Government.
