### **ORDER:**

The Government of Telangana vide reference 1<sup>st</sup> cited has appointed **Sri R.Vinod Reddy, Advocate** as **Standing Counsel for TSTRANSCO** both for Service and Non-Service matters before Hon'ble High Court of Judicature at Hyderabad for a period of three years from the date of assumption of charge of the post or till termination of his services, whichever is earlier. Pursuant to the said orders, Sri R.Vinod Reddy, Advocate has assumed charge on 06-04-2015 and looking after both Service and Non-Service matters pertaining to TSTRANSCO before the Hon'ble High Court of Judicature at Hyderabad. The (3) years tenure of the said Standing Counsel was upto 05-04-2018.

The Government of Telangana further vide reference 4<sup>th</sup> cited issued orders continuing the existing Standing Counsel as in-charge Standing Counsel with effect from the date of expiry of his term, as interim measure, till regular appointments are made or until further orders of the Government, whichever is earlier.
