In T.O.O.(Jt.Secy-Per) Rt.No.4229, Dt.31.01.2023, TSTransco issued orders on coverage of Group Personal Accident Insurance Coverage of Rs.50,00,000/- each (or) as per eligibility, whichever is less to 38 Nos. Trained Employees & Artisans working in Hot Lines Wing of TSTransco.

2. In the reference 2nd cited, TSTRANSCO issued orders on revision of Pay of Artisans w.e.f.01.04.2022.

3. In the reference 3rd cited, TSTRANSCO issued orders on revision of Allowances to all the categories of Employees of TSTRANSCO w.e.f.01.04.2022.

After careful examination, TSTRANSCO hereby directs the Chief Engineer/Transmission/VS, Chief Engineers/Zones and All Pay Drawing Officers that the Hot Lines Special Compensatory Allowance shall be paid Grade-Wise Lumpsum Amount to Artisans working in Hot Lines in TSTRANSCO w.e.f.01.06.2023 as follows :-

Sl.No.	Artisan Grade	Hot Line Special Compensatory Allowance in Lumpsum per month
1.	Grade-I	Rs.13,000/-
2.	Grade-II	Rs.10,000/-
3.	Grade-III	Rs.8,000/-
4.	Grade-IV	Rs.7,000/-

a) Hot Line Special Compensatory Allowance shall be paid to the Artisans who are working in Hot Lines.

b) If any Special Pay/Allowance already drawing by the Artisans working in Hot Lines Wing shall be discontinued.

c) The Special Pay/Allowance drawn if any in excess of Hot Lines Special Compensatory Allowance paid now shall not be recovered.

5. The Chief Engineer/IT/TSTRANSCO is directed to make necessary changes in SAP.

6. These orders are issued with the concurrence of the JMD (Finance, Comml.,& HRD) vide Regd.No.2385, dt.16.06.2023.
