Sub: TSTRANSCO - IR Wing - Providing of Compassionate Appointment to Dependent Younger Brother/Sister of deceased Artisan who remained unmarried - Orders - Issued.

Government of A.P. vide G.O.Ms.No.612, General Administration (Services-A) Department, dated 30.10.1991 have issued certain instructions on Scheme of Compassionate Appointments to the dependents of deceased Government Employees. In the above orders, at para 2(i) it was ordered that younger Brother/Sister of the deceased Government Servant who remained unmarried can be considered for appointment under the scheme provided there is no other earning member in the family.

- 2. APTRANSCO duly adopting the above G.O. issued orders vide T.O.O.(Spl.Secy-Per) Ms.No.51, Dt.28.05.2001 directed that the "Younger brother/Sister of the deceased employees who remained unmarried can be considered for appointment under compassionate grounds, provided that there is no other earning member in the family".
- 3. In United Govt. of A.P. in Memo No.17897/Ser.A/2000-1, GAD(Ser.A) Department, Dt.20.04.2000 have issued clarification that the words "remained unmarried" occurring in para 2(i) of G.O.Ms.No.612, GAD (Ser.A) Dept., dt.30.10.1991 are applicable to the deceased Government Employee only and therefore only in cases where the deceased Government Employee happens to have remained unmarried, then only the younger brother/sister of such deceased Government Employee can be considered for compassionate appointment provided there is no other earning member in the family.
- 4. In TSPCC Meeting held on 16.12.2022, the issue of TSSPDCL to provide Employment under compassionate grounds to Younger Brother/Sister of deceased Artisan was discussed and it was decided to follow the procedure being followed in Government in providing compassionate appointment in respect of regular employees.
- 5. Accordingly, TSTRANSCO hereby orders to Provide Compassionate Appointment to dependent Younger Brother/Sister of deceased Artisan who remained unmarried provided that there is no other earning member in the family subject to fulfillment of other conditions stipulated in Compassionate Appointment Scheme orders issued from time to time to the depedents of deceased regular Employees/Artisans.
- 6. This order issues with the concurrence of JMD (Finance, Comml., & HRD) vide Regd.No.579, dt.08.02.2023.
