Ltd.

After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS Transco and as per delegation of powers ordered in TOO.Ms. No.301, dt.31.3.2009 read with Memo dt. 22-10-2020, the Joint Managing Director (Fin, Comml. & HRD) hereby accords sanction for an amount of Rs.2,97,896/-(Rupees Two Lakhs Ninety Seven Thousand Eight Hundred and Ninety Six only) from General Ceiling to Yashoda Hospitals, Malakpet, Hyderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.15,500/- (Rupees Fifteen Thousand Five Hundred only) towards the excess amount claimed by Yashoda Hospitals, Malakpet, Hyderabad.
