**ORDER:**

In the reference 4<sup>th</sup> cited, the Director, Omega Hospitals, Banjara Hills, Hyderabad has preferred (4) Nos. credit medical bill amounting to Rs.2,45,785/-(Rupees Two Lakhs Forty Five Thousand Seven Hundred and Eighty Five Only) towards the medical treatment extended to Sri.K.Ramulu, JLM, ID:No.1074017, O/o.SE/OMC-Circle/TSTransco/Mahabubnagar, as in-patient from 30.05.2023 to 01.06.2023, 06.06.2023 to 07.06.2023, 13.06.2023 to 14.06.2023 and 20.06.2023 to 22.06.2023, for “Ca. Right Buccal Mucosa, Radiation by IRGT & Chemotherapy” at Omega Hospitals, Banjara Hills, Hyderabad and requested to issue a cheque in favour of “Omega Hospitals”.

2. After careful examination and Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TS.Transco, and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.3.2009, read with memo dt:22.10.2020, the Joint Managing Director (Fin, Comml. & HRD) hereby accords sanction for an amount of Rs.2,38,734/-(Rupees Two Lakhs Thirty Eight Thousand Seven Hundred and Thirty Four only) for reimbursement of medical charges to Omega Hospitals, Banjara Hills, Hyderabad in full and final settlement of credit bills towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.7,051/- (Rupees Seven Thousand and Fifty One Only) towards the excess amount claimed by Omega Hospitals, Banjara Hills, Hyderabad.

The Pay Officer/TSTransco/VS/Hyderabad is requested to arrange for payment of Rs.2,38,734/-(Rupees Two Lakhs Thirty Eight Thousand Seven Hundred and Thirty Four only) (4Bills) from Major Ceiling to Omega Hospitals, against their credit bills under intimation to the Chief General Manager (HRD)/TS Transco, Vidyut Soudha, Hyderabad.

An amount of Rs.2,34,134/- is sanctioned to Sri.K.Ramulu, JLM, ID:No.1074017, O/o.SE/OMC-Circle/TSTransco/Mahabubnagar, A sum of Rs.4,600/- is recoverable from the employee.The SE/OMC-Circle/TSTransco/Mahabubnagar is requested to recover amount from the employee in installments accordingly and after recovery of the total amount intimate the same with C.B.Voucher No. to the Chief General Manager/(HRD)TS Transco within a month from the last date of recovery from the salary of the employee concerned, failing which disciplinary action will be initiated against the concerned Pay Drawing Officer/Concerned Disbursing Officers.
