ORDER:

- 1. The premises of Vidyut Soudha is provided with both internal & external Fire Fighting System. They play a vital role in preventing and controlling fires, protecting occupants and minimizing property damage. For the maintenance of the External and Internal Fire Hydrant System & Fire Safety Equipment in the premises of Vidyut Soudha, permission was issued to engage retired fire personnel i.e., 1 No. Station Fire Officer (SFO) and 7 No's Leading Firemen (LF) retired fire personnel on contract basis, vide references 1st and 9th cited.
- 2. Further, guidelines for appointing and payment procedure for the 8 No's retired fire personnel were issued vide reference 2nd cited.
- 2. Vide reference 10th cited, orders were issued for extension of permission to engage retired fire personnel on contract basis for a period of six months from 10/08/2023 FN to 09/02/2024 AN, for the maintenance of the External and Internal Fire Hydrant System & Fire Safety Equipment in the premises of Vidyut Soudha. The total permitted strength of retired fire Personnel is 8. i.e. 1 No. Station Fire Officer (SFO) and 7 No's Leading Firemen (LF).
- 4. In view of the completion of permitted period to utilize the services of retired fire department personnel by 09/02/2024 AN, approval is hereby accorded for engaging retired fire personnel on contract basis for a further period of six (6) months from 10/02/2024 FN to 09/08/2024 AN for the maintenance of the External and Internal Fire Hydrant System & Fire Safety Equipment in the premises of Vidyut Soudha. The upper age limit for engaging retired fire personnel may be taken as 67 years for interim arrangement only.

- 5. 1 No Station Fire Officer (SFO) will be paid consolidated monthly pay of Rs. 25,000/- (Rupees Twenty-Five Thousand only) and 7 No. Leading Firemen (LFM) will be paid consolidated monthly pay of Rs. 20,000/- (Rupees Twenty Thousand only) for each person.
- 6. The total financial commitment of Rs 9,90,000/- for six months towards consolidated monthly pay of the Fire Staff (1 No Station Fire Officer & 7 No Leading Firemen) shall be equally borne by TSTRANSCO & TSGENCO.
- 7. The Fire Staff (1 No Station Fire Officer & 7 No Leading Firemen) are kept under the control of the Superintendent of Police, TS Transco (Vigilance), Vidyut Soudha, Hyderabad. He is further directed to submit the Change Return in respect of the above Fire Staff to the Pay Officer, TS Transco, Vidyut Soudha, Hyderabad to arrange the Consolidated Monthly Pay.
- 8. The Pay Officer/TSTransco/VS/Hyderabad is directed to arrange the Consolidated Monthly Pay to the Fire Staff in accordance with para 7 above.
- 9. All other terms & conditions as communicated vide references cited remain unaltered.
