Sub:- Procedure for Shifting of Transmission lines through
TSTRANSCO Portal – Orders – issued.

1. In order to have a transparent system for submission of applications by the requesting agencies and process for sanction and taking up the works, an Application has been developed in TSTRANSCO / TSSPDCL website for “Shifting of EHT Lines”.
2. The Transmission line shifting requests can be uploaded in the portal by the Applicants, with the details of land and the line that is required for shifting, along with the application fee of **Rs. 5,00,000/- + GST**, towards Survey of line and preparation of the estimate. Option can be chosen by the applicant for doing the work by themselves (or) by TSTRANSCO.
3. On submission of the application in the portal, the Chief Engineer / Construction for 132 kV & 220 kV and the Chief Engineer / 400 kV for 400 kV will get the SMS / Mail, for forwarding the application to the concerned area Zonal Chief Engineer and Circle for preparation of estimate. The estimate will be forwarded to the Chief Engineer / Construction / Chief Engineer/400KV.
4. Base principle / Rule for preparation of shifting line estimates, is as detailed below:
 - a) Request for Overhead **(OH)** line to Overhead **(OH)** line. - **Same** capacity **Conductor** will be considered.
 - b) Request for Overhead **(OH)** line to Underground **(UG)** Cable. - A Cable with not less than **double** the power carrying capacity of the existing conductor.

5. The estimate will be scrutinized by Civil, Telecom, Construction and Finance.
6. On approval of the estimate, Demand Notice with Sanctioned estimate and Terms & Conditions of TSTRANSCO will be uploaded in the portal.
7. The portal will communicate to the Applicant through SMS / Mail the sanction of the Estimate.
8. The applicant shall pay the amount through the portal to the Pay Officer/TSTRANSCO, either for doing the work for themselves, by paying the supervision charges **(or)** by paying the total estimate charges, for doing the work by the TSTRANSCO, as per the demand notice communicated.
9. On receipt of the payment through portal,
 - i) Open tenders on e-procurement platform will be called, for doing the work, if TSTRANSCO has to do the work.
 - ii) The Licensed work experience contractor approval, as requested by the applicant will be verified and given for carrying out the work, if TSTRANSCO has to supervise the work.
