O R D E R :

1) As per Section 44AB of Income Tax Act,1961, every person carrying on business, if his total sales, turnover or gross receipts, as the case may be in business exceed or exceeds one crore rupees in any previous year, shall get his accounts of such previous year audited by an accountant. Since, the gross receipts of TS TRANSCO exceed one crore during FY 2020-21, TS TRANSCO is governed by Section 44AB of Income Tax Act, 1961.
