ORDER:

As per Section 44AB of Income Tax Act, 1961, every person carrying on business, if his total sales, turnover or gross receipts, as the case may be in business exceed or exceeds one crore rupees in any previous year, shall get his accounts of such previous year audited by an accountant. Since, the gross receipts of TS TRANSCO exceed one crore during FY 2023-24, TS TRANSCO is governed by Section 44AB of Income Tax Act, 1961.

2) After careful consideration, TSTRANSCO is hereby appoints M/s. M. Anandam & Co., Chartered Accountants, Hyderabad as Tax Auditors to TS TRANSCO for FY 2023-24 (AY 2024-25) with a lump-sum remuneration of Rs.1,25,000/- (Rupees One lakh and twenty-five thousand only) plus applicable GST. The SAO (Budget & Balance Sheet) shall furnish the bill of claim to the Pay Officer accordingly.

3) The Pay Officer, TS TRANSCO, is hereby authorized to release the payment of Rs.1,25,000/- (Rupees One lakh and twenty-five thousand only) plus applicable GST as per the claim raised by the SAO (Budget & Balance Sheet) to the M/s. M. Anandam & Co., Chartered Accountants, Hyderabad towards Tax Audit Fee for FY 2023-24 (AY 2024-25) on completion of Tax Audit and issue of "Audit Certificate" thereon.

4) The said expenditure is chargeable to A/c.No.760110 – Other Professional Charges.
