ORDER:

In the reference 2nd cited, Chief Engineer/Metro Zone/Hyderabad has enclosed the representation dt.05.12.2023 of Smt.Palli Sasikala wherein she is requesting for sanction of Compensation as per Workmen's Compensation Act 1923 as her husband Sri Talla Veerraju, JLM/CBD/Moulali O/o.SE/OMC/Metro-East/Hyderabad met departmental electrical fatal accident at 220 KV SS Moulali and expired on 18.11.2023 while undergoing treatment at M/s.Yashodha Hospitals, Secunderabad.

2. The Workmen's Compensation Act, 1923 provides for payment of compensation to the workmen and their dependents in the case of injury by industrial accidents including certain occupational diseases arising out of and in the course of employment resulting in death or disablement.

3. After careful examination, TSTRANSCO hereby accords sanction a sum of Rs.13,60,275/- (Rupees Thirteen Lakhs Sixty Thousand and Two Hundred Seventy Five only) as Employees Compensation towards final settlement to Legal Heir of Late Sri Talla Veerraju, I.D.No.1073699, JLM who expired due to departmental electrical fatal accident on 18.11.2023 while on duty.

4. The Chief Engineer/Metro Zone/Hyderabad is directed to take necessary action subject to the following conditions.

- a) Legal Heir certificate shall be obtained from the dependents of deceased Artisan issued by the concerned Government Authority.
- b) An undertaking from the legal heir of the deceased worker shall be taken to the effect that there shall be no further liability to TSTRANSCO.
- c) Departmental Officers should make the actual payments directly to the legal heir and utmost care must be taken to ascertain the legal heirs. Proper receipts should be taken expressly reciting that the amount is received in full by the Legal Heir as final settlement of claims against the TSTRANSCO.
- d) The payment should be made without admitting an legal liability
