#### ORDER:

Sri.Younus Saleem Md, Artisan, Gr-II, ID:No.50001209, O/oSE/OMC/ TSTransco/Nalgonda as in-patient from 05.02.2024 to 08.02.2024 for "K Afi?Viral Cholelithiasis Hypothyroid MM" at Yasoda Hospitals, Malakpet, Hyderabad and requested to issue cheque in favour of "M/s Yashoda Health Care Services Pvt. Ltd".

After careful examination under Medical Regulations 4(f) & 9(2) of APSE Board as adopted by TSTransco, and as per delegation of powers ordered in TOO.Ms.No.301, dt.31.03.2009 read with Memo dt.22-10-2020, the Chief General Manager (HRD) hereby accords sanction for an amount of Rs.1,24,557/- (Rupees One Lakh Twenty Four Thousand Five Hundred and Fifty Seven only) for reimbursement of medical charges to Yasoda Hospitals, Malakpet, Hyderabad in full and final settlement of credit bill towards the medical charges mentioned in para 1 above duly deducting an amount of Rs.4,801/- (Rupees Four Thousand Eight Hundred and One only) towards the excess amount claimed by Yasoda Hospitals, Malakpet, Hyderabad.

The Pay Officer/TSTransco/VS/Hyderabad is requested to arrange for payment of Rs.1,24,557/- (Rupees One Lakh Twenty Four Thousand Five Hundred and Fifty Seven only) from general ceiling to Yashoda Health Care Services Pvt. Ltd, against their credit bills under intimation to the Chief General Manager (HRD)/ TS Transco, Vidyut Soudha, Hyderabad.
- 4. An amount of Rs1,24,272/- is sanctioned Sri. Younus Saleem Md, Artisan, Gr-II, ID:No.50001209, O/o.SE/OMC/TSTransco/Nalgonda. A sum of Rs.285/-is recoverable from the Artisan the SE/OMC/TSTransco/Nalgonda is requested to recover the amount accordingly from the salary of the Artisan towards the cost of inadmissible items and intimate the same with C.B. voucher No. to the CGM(HRD)/TSTransco, within a month from the date of recovery from the salary of the Artisan concerned, failing which disciplinary action will be initiated against the concerned Disbursing Officers.
